Remittance of 2022 Chapter Dues/Fees

2. **Remittances (dues&fees) should be received by December 31, 2021** to avoid chapter break in **full** calendar year for 2022 financial membership January 1, 2022 - December 31, 2022
3. **Special request: All Chapter Officers ... *new and continuing* ... please remit dues/fee before Wednesday, December 15, 2021.**
4. The last *post office retrieval of dues/fees* will coincide with the closing of the post office on Friday, December 31, 2021.
5. The last PayPal processing on December 31, 2021, will be 6:00pm.
6. **Full** processing of dues/fees could take up to seven (7) days regardless of when the dues/fees are received. However, every effort will be made to process all remittances received on or before December 31st and January 31st as soon as possible.
7. **Corporate per capita fees are considered late if processed after February 1, 2022, regardless of post mark date(s) and subject to a 10% late fee that must be paid by the Soror. The only Sorors not subject to this rule are Sorors that are reactivating.**

Please note: The corporate office system automatically issues a break in service for any fees processed after February 1, 2022. To ensure that you do not have a break in Sorority service/active membership, the Finance Officers recommend that the remaining Dues/Fees for the 2022 financial year be received by January 15, 2022, to allow for processing time.

8. BASIC \$\$ SCHEDULE: If approved at the November Chapter Meeting ...

Regular Membership (Per Capita - \$125; EAF - \$10; Documents - \$10; Chapter dues - \$140) <i>Returning and Transfer</i>	\$ 285
Life Members (Chapter dues - \$140; EAF-\$10; Documents - \$10) <i>Returning and Transfer</i>	\$ 160
Golden Sorors (50% OMO dues discount-\$70; Per Capita \$125; EAF \$10; Documents - \$10)	\$ 215
Reactivating Soror ... inactive >1 year (Corporate fee \$155; Chapter dues \$140)	\$ 295

9. PAYPAL:

- a. When remitting payment:
 - i. Use **ONLY** “**GOODS AND SERVICE**”.
 - ii. Remittance will be refunded if “Friends and Family” is used to remit fees.
 - iii. **Multiply remittance (total dues/fee) by 3.5%. Fees will be refunded if remittance is less than applicable dues/fees and considered not paid until correct amount is remitted. If you**

choose to remit over the multiplier 3.5%, annotate: *donate overage to the Angel Fund.*

- b. The following information must be annotated with remittance:
 - i. **Full name per Alpha Kappa Alpha Member Roster** and cell phone number e.g., *Soror Sisterly Love, 215-678-0910*
 - ii. Identify purpose of Remittance e.g., *2022 Chapter Due/Fees & donate any overage to the Angel Fund.*

- d. **Please note that if remittance is paid to an account other than the Chapter Operations account indicated above, an undetermined delay in processing your remittance will occur and may result in late fees as well as nonfinancial status could occur. The financial officers will assist in recouping remittance which could take weeks to correct.**

If your PayPal is linked directly to savings or checking account, you will avoid the additional charges incurred by using a credit/debit card.

10. MAIL

- a. Please take into consideration possible postal delays.
- b. Mail check, money order or cashier's check ... do not mail cash.
- c. The full name of the Soror per Alpha Kappa Alpha Chapter Member Roster must be legible and the purpose of the remittance must be annotated e.g., *Soror Sisterly Love, 2022 Dues/Fees & donate overages to the Angel Fund*
